- Your payment in full, along with the applicable refundable deposit is due immediately to book this reservation. The deposit is refundable after final assessment of the party area. Deposits will be returned or refunded within thirty days, to the individual and/or organization indicated on application.
- Cleaning is the responsibility of the rental party. Cleaning includes picking up of all trash and emptying bags into dumpster. If the pavilion area is not left clean and all trash placed in the dumpster, restrooms clean and restroom doors LOCKED, the deposit will not be refunded.
- The Lessee understands that charges for all dates and times scheduled will be charged unless a written notice of changes or cancellation is received by the City at least fourteen (14) working days prior to the event. Less than 14 days notice of change or cancellation is a loss of **deposit**. Reservations may be rescheduled or refunded due to weather conditions or pool closures.
- Assume all liability and hold harmless and indemnify the City, its officers, employees, and agents from any and all liability arising out of the Lessee's use of facilities.
- Accept full responsibility for protecting property and equipment and assume any and all liability for repairs or replacement necessitated by any damage done to building, equipment, or other property used by the Lessee.
